

## DNA Forum Interaction at EB 112



26 October 2021

## Aim of the presentation

 To convey the key messages from DNAs on the CDM, collected through a call for input launched in September 2021 (5 responses received from: Brazil, Burundi, Cape Verde, Guatemala and Guinea Conakry);



- To deliver suggestions to the Board on what they could do to address the concerns/suggestions of the DNAs;
- To receive feedback from the Board.



## DNA inputs to EB 112 (1/4)

#### **Temporary measures:**

- CDM project participants are grateful of the temporary measures;
- Warmly welcomed the temporary measures, because if this decision is not implemented, a vacuum would have been created;
- Ensures the minimum for the CDM project participants so that activities can continue to operate and issue (provisional) credits until an appropriate legitimate decision at COP 26 is made;
- Fate of the CDM activities under the temporary measures (post-2020 cases) are unknown.



## DNA inputs to EB 112 (2/4)

### Consideration of new CDM activities (post-2020 cases):

- One DNA ceased to issue letter of approval until some of the operational criteria for the CDM are defined including means by which to estimate emission reductions and removals, how to technically issue CERs into the Kyoto Protocol registry, and what modalities and procedures are to be applied for the different types of projects.
- One DNA currently has no CDM activity under evaluation, but it is receiving CDM Prior Consideration notifications;
- One DNA is waiting for the approval of its new standard baselines, after which it will have CDM activities to consider.

# DNA inputs to EB 112 (3/4)

#### **Regional CDM support:**

- Greatly appreciate the assistance provided by RCCs, and pleased with the available technical assistance;
- Support logically prioritized for the DNAs of the countries underrepresented in the CDM.
- RCCs can also help the rest of the DNAs with their particular needs, especially after the long period of uncertainty about the CDM, which has undoubtedly reduced their respective capacities;
- Suggestions for enhanced support:
  - To enable DNAs to accomplish role and responsibility at the national level (CDM implementation);
  - To develop and update standardized baselines;
  - To received more information on the CDM.



### DNA inputs to EB 112 (4/4)

### Suggested topics for the global DNA Forum meeting in 2021:

- Latest CDM regulatory development;
- Latest on Article 6 negotiation;
- Capacity-building in:
  - private sector engagement;
  - evaluation and management of CDM activities;
  - Access of countries to international climate finance;
  - Acceleration of actions to develop CDM activities.

The exchange of good practices and lessons learned with the CDM in the region.



### Suggestions to the Board

- Conveyed congratulations and support for the hard work carried out to date in support of thee CDM and its significant contribution to the sustainable development of the Non-Annex I Parties;
- Further develop operational criteria for the CDM (for post-2020 cases);
- Accelerate negotiation on CDM transition to enable DNAs to know the future of their CDM activities;
- Appreciation for the 3 regional forum meetings organized virtually in 2021 and continue sponsoring such meetings to receive latest information on the CDM.
